- a. Conversion price: VND18.293 /share
- b. Conversion ratio and rounding principle
  - Proportion of bonds entitled to convert in the second phase: All the bonds owned by bondholders
  - The Conversion rate is  $\frac{100,000}{18,293}$  shares per bond

Accordingly, (i) the total number of shares that bondholders received from the conversion of bonds shall be calculated on the basis of: the number of bonds that the bondholders decide to convert multiplies (x) with the Conversion rate; and if not an integer, it is rounded down to the nearest integer and (ii) the Issuing organization will not issue shares for the fractional part of shares (if any) and does not pay any amount of money for that fractional part of shares.
